

### An Unfortunate Family \*

Looking through the adjacent list of families listed on the immunisation files, the Anstis family story is one of extreme sadness.

The newspaper articles shown (see page 4) from Trove tell of Mr Anstis being fatally punched in 1914, the family farm being sold up in March 1915, a son killed at Galipoli in May 1915, and a daughter suddenly dying from illness in July 1915.

#### Alleged Murder at Tallygaroopna.

#### FARMER W. H. ANSTIS THE VICTIM

#### A SATURDAY-NIGHT SQUABBLE

Apparently during an argument which took place at the Victoria hotel, Tallygaroopna, on Saturday night, shortly before the closing hour, Orville Byron Randall, as is alleged, struck William Henry Anstis, farmer, a blow under the jaw, sending him to the floor. After that Randall went away, and when taken by the police on Sunday morning and shown the body of Anstis, he exclaimed, horror stricken, "My God ! he's dead !"

Randall has been working for some time at Mr Thomas James Sandilands' sawmills at Tallygaroopna. He is stated to have belonged to the American fleet which arrived at Australia some years ago. He is a tall, powerfully-built man. On Saturday evening, while at the Victoria hotel, at Tallygaroopna, he was in the company of Mr Anstis, who, it is stated, was advising him to go home, and it was during the argument that followed that the fatal blow is said to have been struck. Anstis was removed to the gateway at the hostelry by some of the men who were there; and one of them, half-an-hour later, on going to see how he was getting on, found that he was dead. The body was then removed to the hotel premises ; and in response to a telephone message from Tallygaroopna post-office, Sub Inspector T. Corkhill and Constables .V. Thomas and Cantwell went out to make inquiries.

At the conclusion of this evidence, the inquest was adjourned till Tuesday, 2 p.m. at the Shepparton Court House.

#### A TALLYGAROOPNA CASE. DEATH OF MR. W. H. ANSTIS. CHARGE OF MANSLAUGHTER. ACCUSED DISCHARGED.

In the Court of General Sessions this morning before Judge Box, a young, unmarried man named Orville Byron Randall was presented on a charge of manslaughter. Mr. J. Sutherland acted for the Crown prosecutor, and Mr. W. McAbernethy appeared for the accused, who pleaded not guilty.

The following jury was empanelled: Thomas Hookey, Shepparton, hotelkeeper (foreman); Joseph Cosgrove, Ardmona, orchardist; W. Robinson, Shepparton, farmer ; James Parker, Shepparton, farmer ; David Goodlet,

Shepparton, carpenter; John. T. Buckworth, Kialla, farmer ; Frank K. Howson, Shepparton, dealer ; Samuel James Orchard, Shepparton, farmer ; David Clark, Arcadia, farmer ; Jas. O'Connell, jun., Shepparton, agent; William Henry Clark, Shepparton, farmer; Joseph L. Quinlivan, Shepparton, farmer.

The acting Crown Prosecutor stated that accused was charged with killing one, William Henry Anstis, at Tallygaroopna on the night of 3rd January last. On that night the deceased, Anstis, with a friend, was at the Victoria Hotel, Tallygaroopna, and the accused was also there. About 11 o'clock that night Anstis left the hotel to go home. After going outside deceased was told there was a man (the accused) lying asleep against the wall of the hotel, and it was suggested that he should be seen home to his tent near the railway station. They roused the accused and set him on his feet. He resented interference, and deceased caught hold of him to assist him home. Accused struck a blow which knocked Anstis down. "The blow was somewhere on the head—about the jaw. Deceased fell and never rose again, subsequently dying from the effects of the blow. There was no suggestion of malice, otherwise the accused would have been charged with murder. He was charged with manslaughter, which, subject to his Honor's direction, was the unlawful killing of any person. The case for the Crown was that Anstis death was the direct result of the blow from the accused. Under the circumstances there was neither excuse nor justification for the blow.

The case for the Crown was supported in whole or in part by the evidence of the following witnesses:—John Inglis, hotelkeeper ; Alfred Bolger, laborer; Leslie James Chapman, Constable Vernon and Dr. J. H. Cook. The evidence in question has already been published in the News.

The jury, after a few minutes retirement, found a verdict of not guilty, and the accused was discharged. His Honor gave the young man a kindly admonition to keep away from drink, pointing out the narrow escape he had experienced.

Quite a gloom was cast over the district when it became known that Nellie, the fourth daughter of Mrs. and the late Mr. W. Anstis, of Tallygaroopna, had died suddenly in the Women's Hospital, Sydney, on Friday June 1st, after a few hours illness, the cause of death being kidney trouble.

The deceased, who was only 29 years of age, was born in Clunes, and came to Congupna when only 12 months old. She was of a bright and cheerful disposition and loved by everyone. She was not one of the strongest, but had not been ailing very long. Feeling extra well she went to Sydney six weeks ago where the sad event took place. Her brothers and sisters received a letter from her only two days before her death, stating that she felt splendid. The remains were brought from Sydney and interred in the family grave at Shepparton. The deepest sympathy is expressed for the bereaved mother, brothers and sisters.

First A.I.E.F., No 2124. He was last seen in the trenches on May 7; and we have had no further word excepting the original information from the Defence department on June 23. If any of the returned soldiers could give me any information as to when last seen or what actually happened, I would be very pleased-

## REGISTRATION OF BIRTHS, MARRIAGES AND DEATHS

### INTRODUCTION

The long awaited index of the birth, marriage and death records of the Government Statist have arrived.

Genealogists are now able to do their own researching for a name and upon production of the requisite folio number are able to obtain a certificate, thus avoiding the frustrating situation of receiving a "No record" from the Statist. This issue of "The Golden Age" is mainly devoted to the work of William Henry Archer whose persistence was responsible for Victoria having among the best Birth, Marriage and Death Certificates in the world.

If the father or mother was disabled or deceased, then the occupier of the house (or father, or mother) was to inform the Deputy Registrar *within sixty days* of the situation, to the best of his or her knowledge. Failure to do so brought a fine of ten pounds, and the applicant was warned of perjury.

The Law stated: 'After 60 days it shall not be lawful for the Deputy Registrar or the Chief Registrar to register a birth.' No wonder parents in remote areas missed out on registering their children!

There was only one small window of opportunity for a late registration. This allowed registration *after fifteen days but within six months* if a solemn declaration was made by the father or guardian or a person present at the birth, before the Deputy Registrar or the Chief Registrar (in Melbourne) and signed 'in the book', presumably the birth registration book.

Any attempt to register a birth after sixty days had passed, without making the declaration, carried a further fine of five pounds as did any attempt to register a child after twelve months.

Small wonder, then, that tardy parents avoided registering their children for fear of the fine, which was quite large compared with wages of the time.

Even if you had admitted your error and paid the fine, the child could not be registered after the six month period! One wonders how many parents went to Melbourne, perhaps to relatives, where they were unknown to the neighbours and registered their child as recently born, though several months old! (Though this, too, was perjury, which carried a fine and a prison term.)

### COMPULSORY VACCINATION

From 1 January 1855 compulsory vaccination for smallpox was introduced. The legislation was retrospective, applying not only to the new born, but to any child born after 1 June 1840. On registering the birth, the parent received a vaccination certificate which had to be taken to a doctor designated as Public Vaccinator within three months, and the first vaccination was followed by an inspection on the following eighth day. The doctor's copy, duly signed on completion, was sent to the local Deputy Registrar of Births Deaths and Vaccinations, who recorded, in his vaccination book, the completion of the law's demand. The parent received a duplicate certificate.

Many of these vaccination books survive and some are in local collections kept with local rate books, Board of Health minutes, and the like. But some of the country vaccination books are in the Victorian Public Record Office (VPRO) as VPRS 3654, transferred from the Registrar General's office. If a parent registered their child, say, in Melbourne, and then returned to the family home town, the vaccination was completed in the home town, and in many of these registers, the column 'Where birth registered' was filled in to show that it was not a local registration.

The earliest surviving book in the VPRO is that of Amhurst, commencing 1858, and several: Bendigo, Clunes, Frankston, Rochester, Talbot, Somerville and Smythesdale are as late as 1930. However, there are only forty-one volumes in this series, so many hundreds are either kept locally or destroyed with time. Ten years ago I saw the Winchelsea vaccination books at Council premises, but with council amalgamation, who knows where they are now?

I mention these vaccination books because, in files of the Supreme Court (VPRS 259) which I have studied for this article, several parents claim to have registered their children, received their vaccination certificates to present to the vaccinator, and later found that their children had not been centrally registered by the local Deputy Registrar, for whatever reason. Indeed, some were so informed when they presented their child for vaccination! However, as vaccination was compulsory, the vaccination was carried out and would have been entered in the vaccination book. Some families have kept their copy of their vaccination certificates, so these are often in family papers.

The Deputy Registrar was required to inform parents within twenty days of the birth registration of their obligation to present their child for vaccination. This would be done if he had not already received a completed vaccination certificate for the child from the medical officer. This was to remind the parent that a fine of two pounds was demanded on the first complaint and, if the child was not subsequently vaccinated, the fine could be increased by a magistrate up to a maximum total of five pounds for each child if the law was not complied with.

Supreme Court files show that some fathers deliberately 'concealed the birth' because they did not want their children vaccinated. Thank goodness for our generation that most parents complied in the attempt to eradicate this killer disease, so that now worldwide, smallpox is a rare almost extinct disease, thanks to compulsory vaccination.

### LATE REGISTRATION PROGRESSIVELY ALLOWED

After 1 June 1865 the time to register a child was extended from fifteen to *sixty days* though the fine was kept at ten pounds. Late registration accompanied by a solemn declaration, also still with a fine of five pounds, was now extended to *twelve months*.

A new feature was introduced in 1865 allowing parents, on presentation of a baptism certificate dated within twelve months of the birth, to have the already registered given names changed to the baptismal names without fee, though the original certificate was unchanged, the alteration being recorded in

the margins of the original entry and signed by the Registrar General.

#### LATE REGISTRATION 1890

The 1890 Act allowed late registration of a child *after twelve months, but within seven years*. However the evidence stipulated first, a statutory declaration of the father, supported by a baptism certificate, plus a statement from a midwife, nurse or doctor, or of an inmate of the house at the time. The Registrar General could demand further evidence. If approved, a fee of ten shillings was required.


#### REGISTRATION LIBERALISATION 1899

An order to authorise the late registration of a child *after seven years* could be obtained 'from a judge sitting in chambers in the Practice Court at the Supreme Court or a County Court'.

#### OBITUARY

#### MR. JOHN KITTLE



After an illness of about three months duration the death took place in Melbourne on Monday night of one of Shepparton's best known and respected residents in the person of Mr. John Kittle, aged 47 years. He had been under the care of some of the States most eminent specialists, and all that medical skill and efficient nursing could accomplish was done, but without avail. The deceased gentleman, who was the youngest son of the late Thomas and Elizabeth Kittle, was a native of Whroo, near Rushworth, but was brought by his parents in his infancy to Shepparton, where he lived his useful though comparatively short life in the district, with the exception of two years which he spent in business in Finley, New South Wales. He subsequently entered into partnership as builder, etc, at Mooroopna, with his nephew, John Kittle, acquiring the business previously carried out by William Kittle, another nephew. He was twice married, his first wife being a daughter of the late Mr. W. F. Ford, J.P. of the Shepparton flour mills. His second wife, who survived him, was a daughter of the late Richard Flemming. He has left a family of three—all boys. His brothers are Thomas (Shepparton), Edwin and William (Queensland), and Charles (Cosgrove), whilst his sisters are Mrs, Horsburg and Mrs, Wells, both of Kensington,

The late Mr. Kittle was an active member of the Methodist Church, and was choir master for a period of 25 years. He was also an energetic Sunday School worker, and after a long interval of teaching, he was the superintendent, a position which his many amiable and worthy qualities enabled him to fill satisfactorily.

The funeral which took place yesterday afternoon at the Shepparton cemetery was a solemn function. The body, which had been enclosed in massive oak coffin with silver mountings, was brought from Melbourne by rail on the previous evening, and was conveyed to the Methodist church where suitable provision had been made for its reception. ....

The :Dead March: was played at the close of the address by Mr. F. C. Johns, church organist. The coffin containing the mortal remains was then borne to the waiting hearse outside in Maude Street by former brothers of deceased, who was a member of the Mooroopna Lodge of Freemasons, viz., W.M. Bros. H. Edwards ; Bros. J. Anselmi, E. Little, J. Knight, A. Stevens and W. Wilson. The pall bearers were those who had been associated with him as trustees of the church, viz., Messrs. C. Palling, Jas. Thorn, C. Norton, Geo. Thompson, Robt. Smith, and F. Hebbard. Among the numerous wreaths and globes deposited on the coffin were some beautiful ones from Mooroopna Methodist Church and Sunday School ; the Mooroopna Masonic Lodge, and the trustees of 'the Methodist Church at Shepparton. The service at the graveside was simple, but most impressive, and, as in the church many were moved to tears. Revs. E. Smith and H. P. Phillips officiated. Deceased was accorded a Masonic funeral, and the beautiful service of the Order was read by W.M. Bro. H. Edwards.

#### Memorial to John Kittle

A marble table commemorates John Kittle, a prominent worker in the church since its inception. John Kittle died in 1915.

A solemn and an affecting service took place last night at the Maude-street Methodist Church. It was the unveiling of a fine tablet in memory of the late Mr. John Kittle,



whose work in connection with the church will live long after his death, which took place nearly 12 months ago.

The ceremony of unveiling the tablet was unostentatiously performed last night by Mr. Ralph Longstaff, J.P., who, with his devoted partner in life, has been a prominent church worker since its inception in Shepparton. At the close of his sermon, which was of an appropriate nature, the Rev. Ernest Smith, circuit superintendent, invited Mr. Longstaff to perform the ceremony. Mr. Longstaff briefly said : I thank the trustees and officers of this church most heartily for conferring on me the honour of unveiling this beautiful marble tablet to the memory of one whom we all loved and respected for his high character, his beautiful life and his faithful services. The veil was then dropped and the tablet, speaking so eloquently of the virtues of the dead, was exposed to view for all time.

## Finding Missing Baptisms

Parish church registers are really useful records, particularly for taking you back before civil registration began, but it is not all plain sailing.


When hunting for any elusive record of a family event, it's good practice to consider five points.

- **Perhaps the event in question never happened.**  
It was common practice to charge for baptisms, possibly unaffordable for poorer families
- **It may have happened at a different date to that anticipated.**  
Many of our ancestors did not know their own age, guessed it or lied about it.
- **The ancestor's name in the records may not be the same as the one you are looking for.**  
A number of reasons for this:  
Incorrect spelling.  
A single mother may have used her surname for baptism and later remarried.  
Adopted children often took on the surname of the new family.
- **The event could have happened somewhere you haven't expected.**  
Search neighbouring parishes to expected one.  
Check parishes where grandparents lived.  
Born at sea or abroad?
- **It may have been recorded wrongly at the time or transcribed incorrectly later.**  
Priests made mistakes in recording baptisms.  
Transcribers make mistakes.  
Scanning programmes can miss pages.
